This file includes correspondence between Rev. W.H. Hughes, 1954, and the Conference archivists concerning information available about Union Churches. Some original archival material and some handwritten copies of archival material were sent to Rev. Hughes by the Conference archivists. After the death of Rev. Hughes, his daughter, in 1955, returned all the material to the Conference Archives along with information that appears to have been collected or written by Rev. Hughes. The file thus includes copies of documents located elsewhere in the Conference Archives and also original information. The letters of 1954 and 1955 only have significance in so far as they explain how the file came into existence

The file includes "The Union Churches of Western Canada," "The Evolution of Organic Church Union in Canada," lists of Union Churches of various types in Western Canada, a letter "To the Editor of the Presbyterian Witness," "The Local Union Story" written by Rev. W.H. Hughes in 1955, and histories of Local Union Churches at Loverna, Aneroid and Conquest, "The Story of Local Union Churches in various Communities in Saskatchewan" prepared by Rev. Hughes, and "History and Objective of the Union Churches of Western Canada."
