Biography: Leonard Murray Findlay was born in Aberdeen, Scotland in 1944. He earned a M.A. in 1967 from the University of Aberdeen and a D. Phil in 1972 from the University of Oxford. Dr. Findlay taught at City of Birmingham Polytechnic before joining the University of Saskatchewan English Department in 1974. He rose through the ranks becoming a full Professor in 1983. Dr. Findlay's research interests include critical theory, disciplinary history, cultural studies and 19th Century European literature and culture. He has also studied, written and lectured on the university in the modern world. He has a particular interest in academic freedom and the corporatization of universities. The U of S community has recognized Dr. Findlay several times including the Academic Freedom Award from Faculty Association, 2011, D. Litt from University of Saskatchewan, 2011 and the University of Saskatchewan Students' Union Teaching Award, 1995 and 1997. He is a Distinguished Professor Emeritus, Director of the Humanities Research Unit, a founding member of the Indigenous Humanities Group and Past President of Academy One (Arts and Humanities) of the Royal Society of Canada. He was named a Fellow of the Royal Society of Canada (RSC) in 2007 and was awarded the title Distinguished Chair in 2015.

Scope and content: This fonds contains correspondence, diaries, minutes, research material, published and unpublished articles and presentations that document the interests and career of Lenard Findlay. There is also material pertaining to a number of university and external organizations, societies, committees and organizations.
