Correspondence of Rev. D.S. Dix, Synodical Treasurer of the Church Union Expense Fund concerning collections for the Fund. A committee was appointed by the Synod to collect money which was then forwarded for the use of the national committee.

The correspondence is mainly about the amounts collected but a few letters mention problems or success in making collections. A letter of December 1, 1923, from Rev. D.G. Cameron, Swift Current, states his reasons for not supporting Union, hence his inability to collect for the Fund. The file also includes a copy of the Minutes of Church Union Synod Committee, November 11, 1924.
